# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.gussiehopkins.com, and Hopkins Consulting, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Hopkins Consulting, LLC include www.gussiehopkins.com, Hopkins Consulting, Straight Talk PM and www.straighttalkpm.com. ### **Collection of your Personal Information**

In order to better provide you with products and services offered, Hopkins Consulting may collect personally identifiable information, such as your:
